FH/10/05647/DOM - Mrs. S. Hodge, Downfold, 9, Glebe Road, Fernhurst, Haslemere. Alterations and extensions to existing bungalow to provide first floor accommodation and increased ground floor accommodation.

It was proposed by Mrs. Braithwaite and seconded by Mr. Cottam that the Parish Council recommends approval of the application. Carried.

FH/10/05533/FUL - Mr. & Mrs. Cummings, Tumblewood, Fernden Lane, Haslemere. Demolition of existing dwelling and replacement with new in similar position.
